

Now the approval of Ministry of Education, Govt. of India is hereby being conveyed to you for introducing Vocational Education in alignment with National Skills Qualification Framework (NSQF) in 52 Govt. Schools (List enclosed as Annexure-I).

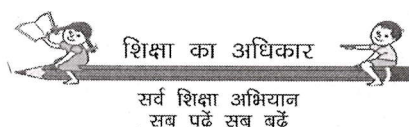
In this regard, an orientation programme of the school Principals, as per enclosed Annexure-I, is to be organized by the concerned District Project Coordinators to make them aware about the salient features of Vocational Education as mentioned in enclosed Annexure-II, before 10<sup>th</sup> of May, 2023.

You are requested to direct the concerned Principals of 52 Govt. Schools to ensure the enrolment of students in skill subjects introduced under Vocational Education. The transaction of course curriculum should be covered through mapping of existing Vocational Teachers, till the time new vocational teachers are deployed in these schools. The detailed guidelines regarding enrolment of students and transaction of curriculum earlier shared in existing 1186 schools will remain same for these new 52 schools covered under Vocational Education (Guidelines enclosed as Annexure-III).


